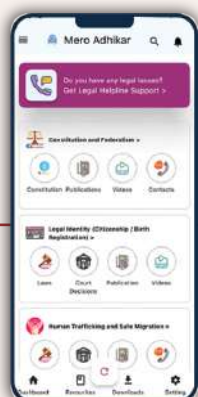

3-Day District-Level Multi-Stakeholder Training on Addressing SGBV through a Victim-Centric Approach and SRHR

✦ April 3-5, 2026, Doti ✦

FWLD successfully organized a 3-day Training for DistrictLevel Multi-Stakeholders on Addressing Sexual and GenderBased Violence (SGBV) through a Victim-Centric Approach and Sexual and Reproductive Health Rights (SRHR). The training brought together representatives from key district-level institutions, including the Doti District Court, One-Stop Crisis Management Center (OCMC), District

Government Attorney's Office, District Police Office, Legal Aid Committee, as well as law practitioners, mediators, and judicial committee members. Medical jurisprudence and protection of evidence a highlight of the training was a Mock Trial, in which participants role-played a hypothetical domestic violence case, representing their respective institutions. The exercise enabled participants to view

issues through a survivor's lens and identify areas for improvement in delivering victim centric services. Mr. Binod Chandra Devkota welcomed the participants and outlined the program's objectives. The sessions were moderated by Advocate Bal Bahadur Kunwar, with coordination support from Ms. Kiran Kunwar.

Experts from the judiciary, prosecution, police, health sector, and legal profession led sessions in their respective fields of expertise. A key highlight of the training was a mock trial on a hypothetical domestic violence case, enabling participants to apply

a victim-centric approach and strengthen inter-agency coordination. The three-day program was inaugurated by Honorable Kamal Prasad Gyawali, Judge of the District Court, and concluded by Ms. Phul Kumari Thanet, Deputy Mayor of Kawasoti Municipality.

Advocate Bhupendra Khanal welcomed participants and outlined the program objectives, while Advocate Nabin Kumar Shrestha moderated the sessions with coordination support from Ms. Sunita KC.

The practical exercise encouraged participants to better understand survivors' experiences and reflect on improving coordinated, victim-centric responses.

- ▶ Gender-responsive and victim-centric investigation and response mechanisms
- ▶ Judicial approaches to SGBV cases
- ▶ Interim relief, protection, and compensation provisions
- ▶ Medical jurisprudence,

forensic evidence, and evidence preservation procedures

A key feature of the training was the Mock Trial Exercise, in which participants assumed the roles of various institutions involved in handling a domestic violence case. The simulation provided a practical learning opportunity to examine survivors' experiences, strengthen institutional coordination, and promote a more effective victim-centric response system.

Showcasing a Theatre performance 'PRIMA FACIE'

FWLD, in presentation of Katha Ghera, showcased a theatre performance, "PRIMA FACIE," at Kausi Theatre, Teku. FWLD is grateful to the entire team of Katha Ghera, especially Pashupati Rai, who was the solo performer on stage, and Akanchha Karki, the director of the show. The performance presented the perspective of rape victims, revolving around laws, practices, the judicial system, and existing gaps.

The performance was followed by a panel discussion where Mr. Parashwor Dhungana (Secretary, Ministry of Law, Justice and Parliamentary Affairs), Ms. Bina Dahal (Assistant Government Attorney, Office of the Attorney General), and Senior Advocate Meera Dhungana were guests. They

shared insights based on their experience, expertise, and roles as members of the "Study Committee" formed by the Ministry of Law, Justice and Parliamentary Affairs to study about the necessary reforms in laws against sexual violence, including rape. At the end, Advocate Padma Acharya, Advocate Karuna Parajuli, Advocate Bishnu Bashyal (Dr.), Advocate Sagar Pathak, Advocate Luma Singh Bishowkarma, and Ms. Aruna Joshi including others shared their reflections and comments on the subject matter. The panel was facilitated by Advocate Rojina Shrestha whereas the program ended with Advocate Sabin Shrestha extending vote of thanks to the team, panelists, and participants.

Endorsement of Local laws and Mechanisms against SGBV

Different Municipalities around the country adopted laws and Policies against Sexual and Gender-based Violence (SGBV). FWLD, collaborated and supported the local organizations such as IHRC, HuRENDEC Nepal, SAADA Nepal, KIRDARC, PACE Nepal, CAD Nepal and several Municipalities in drafting and adoption of the local laws and mechanisms

against (SGBV). Through a series of coordinated advocacy efforts, Municipalities adopted the laws and policies against SGBV, tailored to their needs and context. Following the adoption, the Municipalities in collaboration with FWLD and respective local organizations, disseminated the endorsed laws and policies publicly and also felicitated FWLD for the overall support.

- Khajura Rural Municipality adopted and publicly disseminated the Sexual Harassment at Workplace (Prevention) Code of Conduct on April 16, 2026.

Mapping the Existing Service and Mechanism, Priority of Local Government and Gaps to Work on the GBV

FWLD in collaboration with Sinja Rural Municipality, Plan International and PACE Nepal conducted a "Mapping and Orientation Program of policies against Violence against Women and girls". The program was chaired by Ms. Sitali Rokaya (Vice-chairperson, Sinja Rural Municipality). The program saw the participation of ward-chairperson, members of executive committee, members of judicial committee,

girls club members and representatives of CBOs. The participants shared the existing VaWG and the policies against it the Rural Municipality. Advocate Rojina Shrestha delivered the presentation and identified the gaps in existing laws. Mr. Santosh Chaudhary welcomed and highlighted the objectives of the program whereas the program was moderated by Ms. Basana Budha.

Sharing and Consultation with the local government on identified gaps and planning for the next step

✦ May 13, 2026, Jumla ✦



FWLD, in collaboration with Sinja Rural Municipality, Plan International, and PACE Nepal, conducted a "Sharing of Identified Gaps, Consultation, and Planning Meeting". Advocate Rojina Shrestha shared the gaps identified after mapping existing laws and policies related to Violence against Women and Girls (VaWG) with the participants.

Ward chairpersons, members of the Executive Committee, members of the Judicial Committee, and the Vice-Chairperson of the Rural Municipality committed to enacting an Act related to the operation and management of the GBV Elimination Fund, as well as the Rehabilitation and Service Centre and Fund. The meeting asked FWLD to provide technical support in this process. The Vice-Chairperson of the Municipality delivered the closing speech, highlighting the importance of local laws and policies to address VaWG.

Policy Handover to Sinja Rural Municipality

Local-Level Consultation on the Formulation of an Act for the Establishment and Operation of a Fund and Rehabilitation Center for Survivors of GBV, TIP and DV

In collaboration with various rural municipalities and with support from Australian Aid, FWLD organized local-level consultations on a draft Act to establish and operate a Fund and Rehabilitation Center for survivors of gender-based violence (GBV), trafficking in persons (TIP), and domestic violence.

The consultation aimed to strengthen the local government's legal and institutional mechanisms for the protection, support, and rehabilitation of survivors of gender-based violence, trafficking in persons, and domestic violence by facilitating

discussions on the proposed local legislation.

During the program, FWLD formally handed over a draft Act on the Establishment and Operation of a Fund and Rehabilitation Center for Survivors of Gender-Based Violence, Trafficking in Persons (TIP), and Domestic Violence to municipalities for consideration and further legislative process.

In recognition of FWLD's initiation and facilitation, various rural municipalities presented a Certificate of Appreciation and a token of love to the organization.

FWLD organized a discussion program with Members of the National Assembly on the critical issue of Technology-Facilitated Gender-Based Violence (TF-GBV) in Kathmandu. The program was honored by the presence of two distinguished special guests:

- ▶ Hon. Puja Chaudhary, Chairperson, Public Policy and Delegated Legislation Committee

25 Members of the National Assembly actively participated in the discussion, reflecting strong legislative interest in

addressing TF-GBV. Advocate Indu Tuladhar delivered a comprehensive presentation on the context and current situation of TF-GBV, covering the international legal framework as well as the existing domestic legal landscape of Nepal. The special guests emphasized the urgent need for dedicated legislation to effectively address TF-GBV. The program was moderated by Advocate Smriti Moktan and concluded with a vote of thanks by Advocate Sabin Shrestha. FWLD remains committed to advocating for laws and policies that protect women and girls from all forms of gender-based violence, including those perpetuated through technology.

Election Observation of HoR 2026 from GEDSI Perspective

Discussion Program on the Draft Report of Election Observation

✦ April 1, 2026, Kathmandu ✦



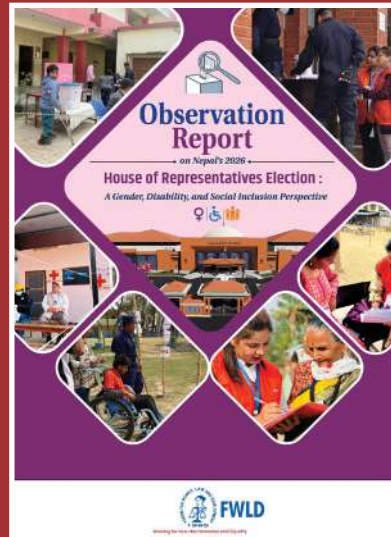
FWLD organized a discussion program in Kathmandu on the draft report of the observation of the House of Representatives Election 2026 from a GEDSI perspective. The session brought together members of the Election Coordination Center, a coalition of 15 organizations working for the rights of women through an intersectional approach. The election observation was jointly

conducted by 14 organizations under the leadership of FWLD. Advocate Seema Dharmi presented the draft report, followed by an engaging discussion where participants shared valuable inputs, insights, and field experiences to strengthen the report. The program was facilitated by Advocate Smriti Moktan.



Launching of Election Observation Report

✦ June 8, 2026, Kathmandu ✦



FWLD organized a program to launch the "Observation Report on Nepal's 2026 House of Representatives Election: A Gender, Disability and Social Inclusion Perspective". The program was chaired by Sr. Advocate Meera Dhungana, and the Chief Guest was Hon'ble Dr. Janaki Kumari Tuladhar, Commissioner, Election Commission of Nepal. FWLD, in collaboration with 14 CSOs, observed the election from a GEDSI perspective, deploying 160

observers across 23 different districts covering all 7 provinces. Advocate Sagar Pathak presented the key findings of the observation report, highlighting the need to reevaluate election centers to make them friendly to elderly citizens, persons with disabilities, pregnant women, sick people, and others who require special assistance. Additionally, he stressed the need for a law mandating political parties to allocate seats for female

candidates in first-past-the-post elections. Hon'ble Dr Janaki Tuladhar stated that the Election Commission is looking forward to strengthening the voting process through gender-responsive, disability-friendly, and socially inclusive measures. She noted that many existing shortcomings would be addressed once the Election Bill, currently under discussion, is enacted. The program was facilitated by Advocate Rojina Shrestha.

Landmark Decision on Harmonization of Maternity Leave Provisions



FWLD is pleased to share that the Supreme Court of Nepal has issued a landmark decision mandating the harmonization of maternity leave provisions across all sectors to a minimum of 98 days, addressing long-standing legal inconsistencies that have disproportionately affected working women.

Nepal's legal framework has generally recognized 98 days as the standard maternity leave entitlement. However, several sector-specific laws have provided significantly lower benefits, creating disparities in women's access to maternity protection. For instance, the Labour Act, 2017 provides 60 days of leave, while other provisions – including the Child Labour (Prohibition and Regulation) Rules, 2006 (90 days), Nepal Health Service Regulation, 1999 (60 days), National Vigilance Police Regulation, 2014 (60 days), Additional Postal Service Rules, 1998 (30 days), Working Journalist Rules, 1993 (60 days), and Armed Police Force Regulations, 2016 (60 days) – fall below the recognized standard.

Challenging these discrepancies, the Forum for Women, Law and Development (FWLD) filed a Public Interest Litigation (PIL) seeking uniform implementation of at least 98 days of maternity leave across all sectors. The petition argued that the existing variations were discriminatory and inconsistent with constitutional guarantees, as well as Nepal's international commitments under the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW) and ILO Convention No. 183.

The case was argued during the final hearing on 20 April 2026 by Senior Advocate Meera Dhungana, along with Advocates Sabin Shrestha, Sushama Gautam, Nabin Kumar Shrestha, Binu Lama, and Sajani K.C.

A Constitutional Bench led by Acting Chief Justice Sapana Pradhan Malla, and Justices Kumar Regmi, Dr. Manoj Kumar Sharma, Til Prasad Shrestha, and Binod Sharma, issued the writ, affirming the need to align all maternity leave provisions with 98 days standards.

The ruling is expected to have significant implications for gender equality in the workplace, requiring the government to amend or harmonize conflicting legal provisions to ensure equal maternity protection for women across all sectors.

Discussion Program with Multi-stakeholder Service Providers on Addressing GBV and Violence in Reproductive Health

FWLD and Ipas Neapl organized a discussion program in Birendranagar, Surkhet, based on the training manual prepared for an interactive training program with multi-stakeholder service providers on addressing gender-based violence and violence in reproductive health from a victim-centered perspective.

The discussion program brought together the Deputy Mayors and Chairperson of the local judicial committees as well as their members, representatives from the High Court, District court, District Government Attorney's Offices, Stipend Lawyers, One-stop Crisis Management Centers (OCMC), District Police Offices, Legal Aid Committees, as well as Senior Lawyer and Legal Practitioners, Mediators, and District-level Organizations.

The session was facilitated by Dr. Deeb Dangol Shrestha from Ipas Neapl, Advocate Nabin Kumar Shrestha and Advocate Smriti Moktan from FWLD, and coordinated by Advocate Geeta Koirala.

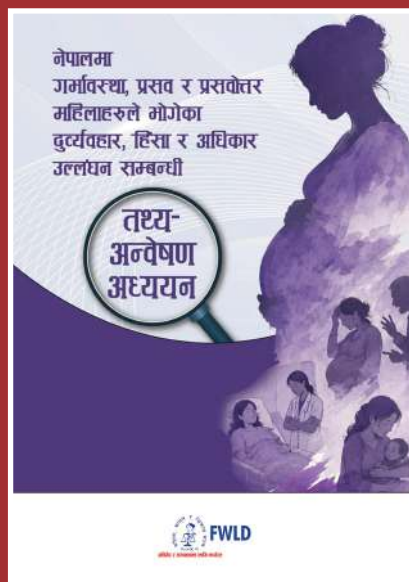

Higher incidence of obstetric violence even in educated, urban households: Report

A fact-finding study conducted by Forum for Women, Law and Development (FWLD) on abuse and violence committed against women during pregnancy, childbirth and postpartum in Nepal, has found that one-third of women during pregnancy, childbirth and postpartum periods have experienced violence.

FWLD Advocate Deepesh Shrestha said most victims were housewives, with perpetrators including family members, relatives, neighbours, and husbands. Service providers, including healthcare professionals, were also found to be involved in some cases.

FWLD Executive Director Sabin Shrestha said that compared to rural areas, women in urban areas experienced more violence and perhaps because they are more sensitised about their rights. He said pregnant women in Madhes Province and postpartum women in Sudur-pashchim Province experienced higher levels of emotional violence.

The study included 1,680 women and was carried out across 28 local levels in 14 districts of all seven provinces. The data shows that 38.4 per cent of pregnant women, 37.9 per cent of women during childbirth, and 35.9 per cent postpartum women experienced violence from family/relatives.

Orientation Program for SRHR Provincial Champions

An orientation program was conducted to empower provincial champions of SRHR. The program provided a comprehensive dive into various SRHR components

led by legal and reproductive health experts. Advocate Nabin Kumar Shrestha, Ms. Madhabi Bajracharya and Advocate Deepesh Shrestha led sessions on intersection of SRHR and

human rights, safe abortion and the prevention of obstetric violence. The program was moderated by Ms. Didkiksa Singh.



Consultation Meeting on Draft Policy Brief Paper

✦ April 28, 2026, Lalitpur ✦

A consultation meeting was conducted to discuss a draft policy brief. This policy brief highlights the need of a respectful maternity care and protection from obstetric violence. Advocate Deepesh Shrestha presented the policy paper, followed by an open discussion where the participants offered their insights. The attendees included lawyers, RH experts, researchers, representatives from civil societies and media personnel. The program was moderated by Advocate Smriti Moktan.



Dissemination of Advocacy Paper and Discussion on Strategic Pathways

A dissemination program for an advocacy paper on family planning and a discussion on strategic pathways was conducted. The paper advocates for strengthening family planning initiatives as a core component of sexual and reproductive health rights, emphasizing the urgent need

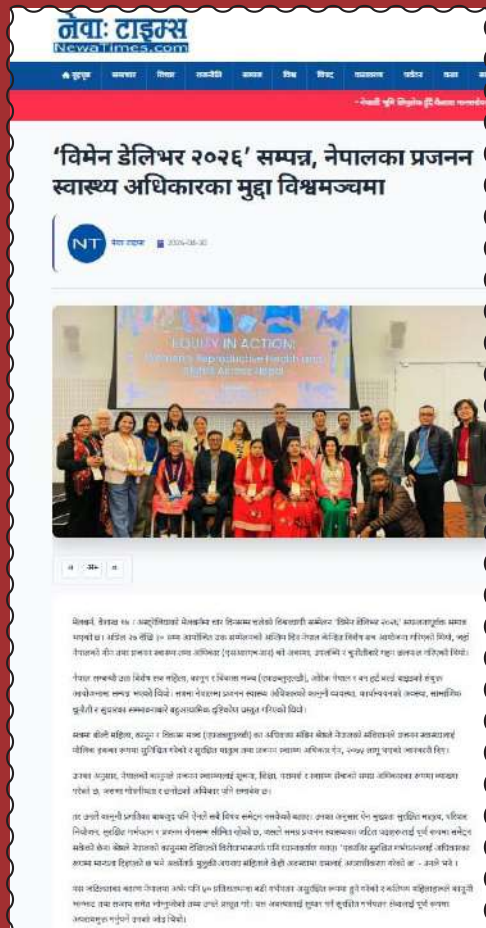

Residential Constructive Dialogue on "Situation of Obstetric Violence in Nepal and the Necessity of Laws Addressing the Violence" with Honorable Members of the National Assembly

✦ May 15-16, 2026, Nagarkot ✦



FWLD organized a two-day residential dialogue with Honorable Members of the National Assembly to discuss the widespread yet overlooked issue of obstetric violence – abuse, neglect, and violation of women's rights during pregnancy, childbirth, and the postpartum period.

The program aimed to share findings of FWLD's Fact-Finding Study on obstetric violence, review existing legal provisions and gaps in Sexual and Reproductive Health Rights, and build parliamentary commitment towards dedicated legislation addressing obstetric violence in Nepal, in line with recommendations from the CEDAW Committee and UPR. The program opened with remarks and objectives by Sr. Advocate Meera Dhungana, followed by a powerful Forum Theatre performance on obstetric violence by Vajrapani Arts Pvt. Ltd. (directed by Mr. Robin Dong Tamang) to set the



context, followed by interactive discussions.

Advocate Binu Lama presented key findings from FWLD's study and highlighted the necessity of laws addressing obstetric violence and ensuring respectful and dignified maternity care, which sparked in-depth discussion among the members. Advocate Binod Chandra Devkota successfully moderated the sessions.

Total of 28 Honorable Members

of the National Assembly participated in the program. They acknowledged that obstetric violence, though common and even personally experienced by some members, has long been overlooked and normalized.

The members committed to raise and champion this issue within the National Assembly and its committees

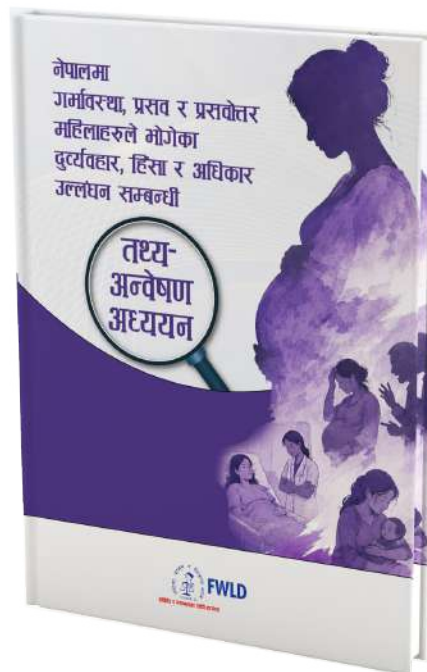
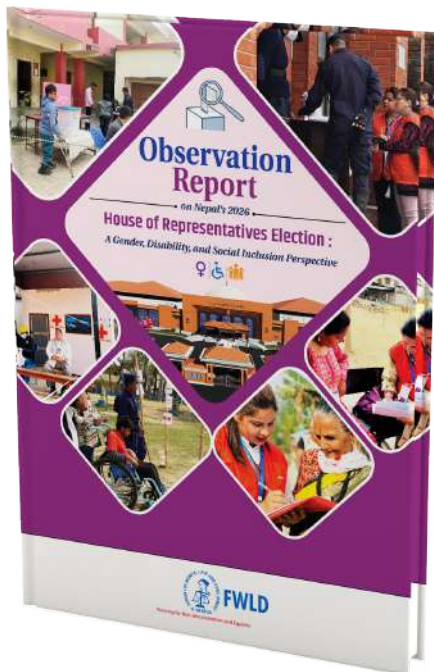
On 30 June 2026, Nepal's report under the fourth cycle of the Universal Periodic Review (UPR) was formally adopted during the 62nd Session of the United Nations Human Rights Council in Geneva. Out of 284 total recommendations received, Nepal has formally accepted 225, noted 57, and commented on two. Representing civil society, Advocate Sabin Shrestha, on behalf of the Forum

for Women, Law and Development (FWLD) and Equality Now, delivered a joint oral statement highlighting three major legal concerns in Nepal: expanding the legal definition of rape to include all forms of non-consensual sexual penetration, removing the statute of limitations for filing rape complaints, and providing legal protection for women in the informal sector.

Need for full legalisation of abortion stressed

Rights activists and lawmakers emphasised the need for full decriminalisation of abortion.

At present, a pregnant woman or girl can seek abortion only till 28 weeks of pregnancy with the consent of the concerned party.

Advocate Nabin Kumar Shrestha made a presentation at an interaction organised by Ipas Nepal and Forum for Women, Law and Development saying that even in cases where the pregnancy has resulted from rape or incest involving a minor girl or even when it is known that the mother's health is in danger or the fetus has genetic abnormalities, women may still be forced to continue the pregnancy and give birth, even at the risk of their own lives.

Shrestha cited a 2022 study conducted in Nepal by the Family Welfare Division and Ipas which states that around 52 per cent of abortions in Nepal are unsafe.

Call for decriminalisation of abortion in Nepal

The four-day global conference Women Deliver 2026, held in Melbourne from April 27 to 30, concluded successfully. On its final day, a special session focused on Nepal explored the country's status, achievements, and challenges in sexual and reproductive health and rights (SRHR).

The Nepal-focused session was jointly organised by Forum for Women, Law and Development (FWLD), Orek Nepal, and One Heart Worldwide. It brought forward a multidimensional discussion on Nepal's legal framework, implementation gaps, social barriers, and opportunities for reform in reproductive health rights.

Speaking at the session, FWLD advocate Sabin Shrestha highlighted that Nepal's Constitution guarantees reproductive health as a fundamental right and that the Safe Motherhood and Reproductive Health Rights Act, 2018 is in force.

According to him, Nepal's legal framework defines reproductive health as a comprehensive right encompassing access to information, education, counselling, and health services, including privacy and the right to choose.

However, he noted that despite legal progress, the law does not cover all aspects comprehensively. It remains largely limited to safe motherhood, family planning, safe abortion, and reproductive diseases, leaving out more complex dimensions of reproductive health.

Findings on HoR election made public

Fifteen organisations, including Forum for Women, Law and Development, that had observed the House of Representatives election held in March, with a gender, disability and social inclusion perspective, made public their findings, recommending a slew of measures to ensure a free, fair and inclusive electoral process.

Advocate Sagar Pathak, who is associated with FWLD, shared the details of the findings at an interaction organised by FWLD, saying that the monitoring report covered all the issues that need to be addressed to make the election free, fair and inclusive.

Pathak said the report recommended that the government needed to make all polling stations physically accessible through ramps, wheelchair-friendly entrances, accessible voting booths, and priority service arrangements for voters with disabilities.

Executive Director of FWLD Sabin Shrestha said that at present visually impaired voters were allowed to bring their own

cess next time. Senior Advocate Meera Dhungana said that if the recommendations of the report were incorporated, the next election would be fairer and more inclusive.

The monitoring report recommended the government to establish mandatory candidacy quotas, reserved seats, or other affirmative measures within the FPTP system to ensure the proportional election of women, Dalits, persons with disabilities, indigenous peoples, Madhesis, and other marginalised communities.

The observation report also stated that the government needed to provide specialised training to polling officials and volunteers on assisting voters with disabilities respectfully and effectively while protecting voter secrecy and dignity. The report calls for institutionalising GEDSI reporting and dedicated budget for GEDSI election infrastructure. It calls for ensuring overseas voting rights for Nepali migrant workers living abroad in accordance with the Supreme Court ruling.
